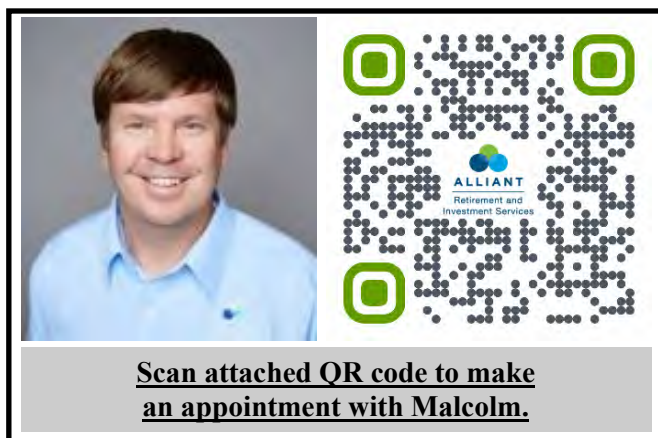

**United Launches CBP's International Remote Baggage Screening on Select International Flights**  
**September 29, 2025**



United today announced the launch of a new U.S. Customs and Borders Protection (CBP) initiative, the International Remote Baggage Screening (IRBS), for connecting passengers with checked bags that eliminates re-checking bags on select international routes, making the connecting experience even easier and reducing potential missed connections. The new process is currently available for United customers traveling on United's daily service from Sydney, Australia (SYD) to San Francisco, California (SFO) with a connecting flight to a final destination.

Since launching the initiative, more than 160 passengers on each flight used the new process. These customers saved up to 45 minutes in their connection journey, relieving the stress of making their connecting flights to their final destinations.



Here's how the process works for connecting passengers on the Sydney to San Francisco flights:

- ▲ Check bag at SYD – Travelers drop off checked bags as usual with an agent at the check-in counter in the lobby.
- ▲ Arrive at SFO – Passengers connecting on a flight to another destination go to CBP for customs, immigration and agriculture inspections and then head directly to TSA for security screening – removing the step for these travelers to pick-up checked bags at baggage claim and re-check them to their final destinations, unless specifically referred by CBP for further inspection. As the flight is heading to the United States from Sydney, United, CBP and TSA work together to screen checked bags and once the flight arrives, the bags are loaded onto connecting flights.
- ▲ Pick-up at final destination – Travelers simply pick-up their baggage at baggage claim at their final destination and head on their way.

*“We’re streamlining the international arrival process by eliminating extra steps for travelers to pick-up and re-check their bags on connecting flights,” said Jennifer Schwierzke, United’s Vice President of Customer Operations Strategy and Execution. “Together with CBP, we’re testing this new process on routes between Sydney and San Francisco and plan to expand to additional international routes in the months ahead.”*

United is partnering with Sydney Airport, Bag-Check and Brock Solutions, leading baggage solution providers, to launch this initiative, streamline the connecting experience for customers and improve the efficiency of the bag inspection process. *“It’s great to see United Airlines trialing bag re-check elimination on the Sydney - San Francisco route, one of our busiest long-haul services,”* said Scott Charlton, Sydney Airport CEO. *“It’s a win for passengers – saving valuable time, making connections easier, and showing how Sydney Airport and our airline partners are working together to deliver smoother, more seamless journeys.”*

CBP’s IRBS is the latest way United is improving the connecting experience for travelers. Earlier this summer, United launched new, personalized mobile app features for customers with connecting flights at United’s U.S. hub airports. They can now access a special section of the app that includes a countdown to connecting flights, customized turn-by-turn directions to their connecting gate with estimated walk times, real-time flight status updates, tips for longer layovers and notifications if United’s ConnectionSaver technology has been activated to hold the plane for them. Since launching the features, more than 3.5 million customers have used the new features, achieving a 95% success rate making their connection.

### **United Receives FAA Certification for First Starlink-Equipped Mainline Aircraft** **September 26, 2025**



United today announced the FAA certified its first mainline Starlink-equipped aircraft, and the first commercial flight is planned for October 15.

This certification comes less than five months since the first Starlink-equipped United customer flight on the Embraer 175 regional aircraft and less than a year since United signed the industry’s largest agreement of its kind with SpaceX to bring Starlink’s fast, reliable Wi-Fi service free to MileagePlus members on the airline’s mainline and regional aircraft fleet.

The FAA approved Starlink’s Supplemental Type Certificate (STC) amendment for the Boeing 737-800 to include United’s fleet. United completed the equipment installation on its first mainline aircraft and expects the first Starlink-equipped mainline flight to be onboard a United Boeing 737-800 that will fly from Newark/New York on October 15.

United’s first Starlink-equipped regional flight took place on a regional jet in May 2025, and the airline now has Starlink installed on more than half of the aircraft in its regional fleet. Initial customer scores on those flights have been noteworthy with 90% of customers appreciating the ability to stream onboard with Starlink’s high-speed, easy-to-use and consistent connection.

*“Customers are loving the Starlink experience onboard our regional aircraft, and our first Starlink-equipped mainline aircraft will bring a superior inflight experience to even more people,”* said Grant Milstead, United’s Vice President of Digital Technology. *“We’re working to install Starlink and offer game-changing inflight entertainment experiences like streaming services, shopping, gaming and more.”*

Starlink stands to unlock an incredible onboard experience for United customers – the fastest Wi-Fi in the sky, for free. Starlink continues to secure an FAA STC to install Starlink on every United aircraft type getting the new equipment – more than 16 total regional and mainline aircraft models.

The FAA certification process involves approval of the design, installation, testing and certification of the system to ensure safe and reliable operations. United unveiled the Starlink installation process earlier this year, underscoring the technical operations benefits associated with the equipment, including size and weight as well as the ease of install and maintenance. The Starlink system, when compared to non-Starlink equipment, allows for a faster and simpler installation because it is

lighter, requiring less fuel to operate the aircraft and is more reliable and weather-proofed.

Starlink is free for all MileagePlus® customers and includes game-changing inflight entertainment experiences like streaming services, shopping, gaming and more, thanks to Wi-Fi speeds up to 250 megabits per second (Mbps). Membership to MileagePlus® is also free, and people can sign-up now at [united.com/starlink](https://united.com/starlink).

### **United Celebrates Turnaround at Newark Liberty International and Charts Bright Future September 16, 2025**



United CEO Scott Kirby was in Newark (EWR) today to celebrate the airline's operational turnaround at EWR and discuss the bright future for the carrier's premier East Coast hub. This

summer, United celebrated its best operational summer ever at EWR, putting the airport on par with JFK and LGA for on-time performance. In fact, United flights out of Newark arrived on-time more often this summer than flights operated by airlines out of JFK or LGA.\*

These rankings come as more than six million people flew United on-time through Newark this summer, the most in the airline's history.\*\* In addition, United's Connection Saver technology helped more than 28,000 customers make tight connections in Newark this summer. Looking ahead to this fall and winter, United plans to serve more than 160 domestic and international destinations from EWR – more than any other airline in the New York City area – adding flights to popular cities like Rome, Venice, Porto, Marrakech and Dublin. Domestically, the airline will add flights to Orlando and Fort Lauderdale and new cities including Palm Springs, California; Columbia, South Carolina; and Chattanooga, Tennessee. Additionally, United expects to hire more than 2,500 Newark employees between 2025-2026 and will be the first airline to purchase sustainable aviation fuel (SAF) for use at Newark. *“Newark is operating better than ever and United's future here is bright – that's a credit to the thousands of Newark employees who deliver for our customers and one another every day,”* said Kirby. *“I want to also thank Secretary Duffy, FAA Administrator Bedford, Governor Murphy and all the national, state and local leaders who helped ensure that Newark remains a safe and reliable crown jewel for millions of domestic and international travelers. As the FAA and DOT implement their plan of increased staffing and improved technology, the reliability and on-time performance of Newark will only get better.”*

*“Millions of passengers each year rely on Newark Airport for their travel needs. Over the past several months, we have worked diligently with our partners at*

*the Port Authority and the FAA to move towards a return to full capacity at Newark Airport, and I am pleased with our progress,”* said New Jersey Governor Phil Murphy. *“United's continued investment in Newark Airport will serve as a significant economic driver for our region, creating thousands of new jobs for New Jersey communities. I thank United CEO Scott Kirby for his partnership in supporting our region's world-class transportation infrastructure.”*

In April and May, challenges associated with air traffic control staffing, technology outages and runway construction led to a concentrated number of delays and cancellations out of Newark. But since that time, bookings and customer confidence in flying through Newark have bounced back thanks to efforts by federal officials, the Port Authority of New York and New Jersey and United employees, including:

- ★ Runway construction was completed two weeks early on June 2
- ★ Beginning in May, the FAA limited Newark flight operations to 68 per hour. This was down from a high of 86, a number that was well above EWR's maximum theoretical capacity even in ideal operating conditions. The FAA has tentatively limited flights out of Newark to 72 per hour through summer 2026.
- ★ In July, the FAA installed a new fiber optic network to support the air traffic control system

*“We're building a brand new air traffic control system, and we started by addressing the challenges of outdated technology at Newark,”* said FAA Administrator Bryan Bedford. *“This summer, the FAA took immediate action to relieve substantial inconveniences to the traveling public—deploying a temporary satellite backup system, upgrading fiber optic technology, expanding high-bandwidth telecommunications, increasing controller staffing, and limiting arrivals and departures. Through strong partnerships with the Port Authority and United, we made significant progress this summer.”*

**United invests more in Newark destinations** ~ As the gateway to the Atlantic, Newark plays a critical role in connecting passengers to United's industry-leading international network.

United's most talked about 2025 destination, Nuuk, Greenland, will return to Newark for summer 2026 following a successful and enthusiastic first season.

- ▲ This summer, EWR had more international departures (over 20,000) and more departures to Europe (more than 8,200) than any other hub
- ▲ This summer, all of United's 32 European destinations were served from EWR
- ▲ In 2025, United serves 82 international destinations from EWR
- ▲ EWR serves the most international destinations unique to United (seven) of any hub

- ▲ By the end of 2025, United will have grown its international network in EWR by 12 destinations since 2018, including the six additions this year
- ▲ EWR has more widebody departures than any other United hub

United hiring in Newark ~ United proudly employs more than 14,000 people in the Newark/New York City area, including more than 3,000 pilots at its pilot base and more than 5,700 flight attendants. United looks to hire another 2,500 employees before the end of 2026.

Sustainable Aviation Fuel Comes to Newark ~ United will be the first airline to bring sustainable aviation fuel to Newark, with plans to purchase up to one million gallons from Neste for use at EWR this year. United purchased more than 13 million gallons of SAF in 2024, more than any other U.S. airline.

On October 26, 2024, new airline rules were codified into federal regulation:

- Ticketing sites must display the fare including all taxes and airport fees on the first screen that a fare and schedule is quoted.
- Critical ancillary fees, such as change and/or cancellation fees, checked bag fees for the 1<sup>st</sup> and 2<sup>nd</sup> checked bag, and carry-on bag fees must be visible on the same webpage not merely in a link that causes the user to leave the primary fare page.
- Families traveling with children under 12 years of age will be provided seating together *without extra charge*.
- Passengers legally entitled to a refund must be informed of this option *before* any other alternative flights or alternative forms of reimbursement are offered. If the passenger declines any other alternative offered, the refund becomes automatic, and the airline must proactively provide that refund and not wait for the passenger to request it.
- Checked bag fees will be reimbursed if the bag is

not delivered within 12 hours domestically or 15-30 hours for international flights, depending on length of the flight.

- Wi-Fi, in-flight entertainment, and seat selection fees will be reimbursed if that service is not available

Now, as of October, 2025:

- ▲ The current administration has just eliminated a proposed rule which would have paid passengers up to \$775 for lengthy delays (mirroring how European delayed passengers are compensated). In the UK and Europe, delayed passengers receive between €250 and €600 (\$295-\$704) depending on flight distance and length of the delay, or if the flight was cancelled with less than 14 days notice.
- ▲ US lobbyists are insisting on the removal of the automatic refund policy, ending family seating protections, eliminating fee transparency rules for baggage and seat assignments, and also shrinking protections for disabled travelers.
- ▲ Another requested change is a 2-year statute of limitations on enforcement actions by the Dept. of Transportation on existing policies, so that future demands can be more easily adapted.

US flight cancellation policies vary by airline. The Department of Transportation has no mandatory rule on this issue, leaving it up to the individual carrier to create their own policy. Most carriers offer meal and/or hotel vouchers for extensive delays but only 4 major carriers add additional compensation to passengers when a delay over 3 hours occurs: Alaska, Hawaiian, Jet Blue and Southwest. Those airlines issue vouchers for future credit or travel as well as meal/hotel vouchers.

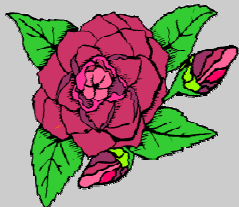
On another topic, be aware that travel authorizations to Europe for US citizens are starting to appear. In my October 2024 article, I included information about the ETIAS – *European Travel Information Authorization System*. The projected start date for that program has been deferred until 4<sup>th</sup> quarter of 2026. However, a separate Entry/Exit program called **EES** has just begun which tracks your entry into the EU and subsequent departure. This system will capture your biometric information from your passport and require you to be photographed or fingerprinted by airport Passport Control agents upon arrival. If you are not staying at a hotel or on a cruise ship you must provide the name and address of private accommodations you have arranged. Most of this process can be accomplished at kiosks in the arrival area. Croatia is the first country to begin the EES process on October 12, 2025, with full implementation to all Schengen countries by April 10, 2026.

I will provide you with updates to the more complicated ETIAS procedures as soon as the EU has finalized their website application process and declared a firm date for implementation. Stay tuned!■

For the price of a first class stamp, you can get about 90 coupons in an envelope. If you have more than one ounce, invest in some additional ounce stamps - the cute ones with the school bus. The coupons have to say Manufacturer’s Coupon. If they come in a strip, please cut them into separate coupons. The collected coupons are then distributed to overseas military personnel for use in their commissaries. The commissaries honor them for six months after the published expiration date so expired coupons can be sent too. However, please send me coupons at least every other month so the troops have a longer time to use them. All of my coupon donors are complaining that they are getting very few coupons now, so the only way we can maintain our level of support is if more people send me coupons. Ask your friends and neighbors, and the people at your RUAEA meetings, to send me coupons as well!

- And: I’m supposed to respect my elders, but it’s getting harder and harder for me to find someone older than me! Love these!

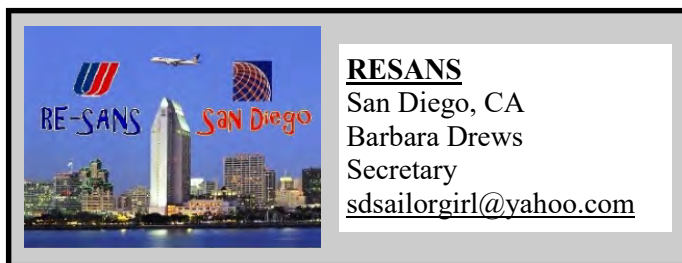
Okay, wrapping this up, our October luncheon, hosted by **Judy & Jack Fitzpatrick**, will be at the Olive Garden in Folsom.

*the GPO Museum, learning about the 1916 Easter Rising and Ireland's modern history.*

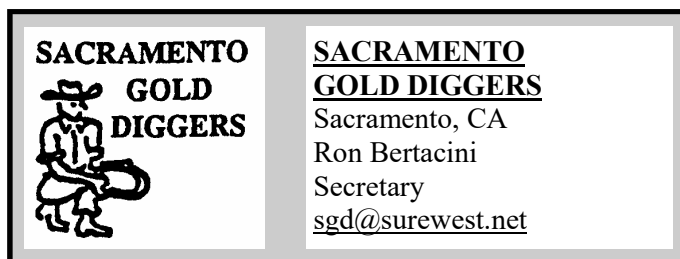
*Traveling on our airline passes made the journey easy, and everywhere we went, the Irish people we incredibly warm and welcoming.*





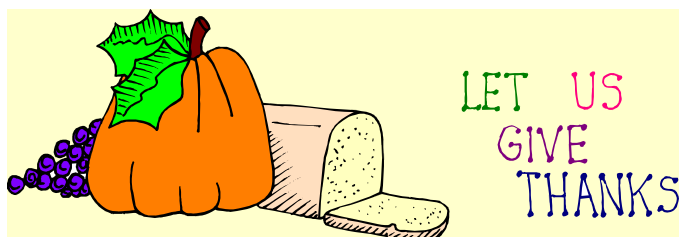

Marty was a proud member of several organizations, including the 301<sup>st</sup> Bomb Group/Wings Association, RUAEA (Retired United Airline Employee Association), Gardenstaters Chapter, Harry Coppendyke American Legion Post 171, and the North Jersey Radio Control Club (Model Airplanes).

Martin was predeceased by his father, Jack Etler; mother, Rose Baruchin; stepfather, Alexander Baruchin; brother, Harold Etler (who died on the beaches of Normandy on June 25, 1944); and his beloved wife of nearly 58 years, Violet "Vi" Etler. He is survived by cousins Harold and Alan Aspis; nieces Sim Van Houwe and Viane Lizza; and nephew David Van Natta.■

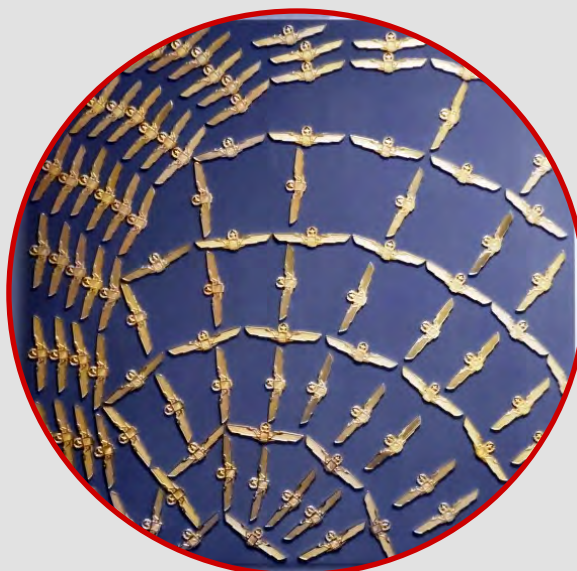
